Washington Has their Eyes on the Work Opportunity Tax Credit



As of August 23rd there are a total of 17 bills that pertain to the Work Opportunity Tax Credit. This includes the Hire Student Veterans Act, INVEST Act, Military Spouse Hiring Act, Hire A Hero Act of 2019 and H.R.2213 a bill from Representative Mike Thompson [D-CA] to amend the Internal Revenue Code of 1986 to make the work opportunity credit permanent. This bill has 25 cosponsors at the moment. At CMS, as WOTC service providers, we would love to see the Work Opportunity Tax Credit not just be renewed before the end of 2019, but become permanent.

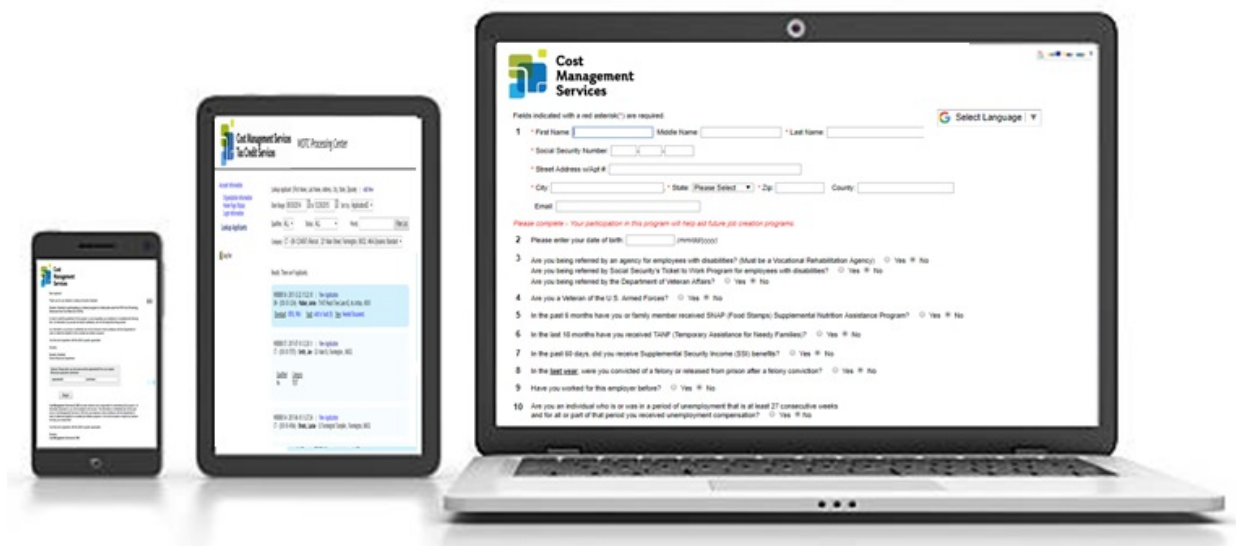

WOTC Questions: Is there any way to qualify for the WOTC if the employee was hired over 28 days ago?



CMS Says: Unfortunately no. The WOTC 28-Day Rule applies. You must submit all WOTC applications within 28 days of the new hire's start date, or they will not qualify. There are very few rare exceptions.
